## LA GARANTIE

En cas d'utilisation de l'attelage, les instructions du constructeur du véhicule concernant le poids tractable maximum autorisé ainsi que la charge verticale maximum sur la boule doivent être respectées. Ces instructions se trouvent dans les documents de bord du véhicule et dans le certificat WVTA. Merci de vous rapprocher du concessionnaire de la marque de votre véhicule afin de connaître son poids maximum tractable. Il est interdit de dépasser les charges données dans les documents qui accompagnent l'attelage.

Avant de tracter, raccorder la connexion électrique, et la chaîne de sécurité qui permet l'arrêt automatique de la remorque en cas de rupture de l'attelage.

Dans un cas extrême, la surcharge de l'attelage peut entraîner sa rupture et la perte du véhicule tracté (remorque, caravane, porte vélo...). La conséquence peut être une blessure grave ou mortelle pour les occupants du véhicule tracteur et/ou les piétons et usagés de la route.

## RADARS DE REcul
